Sir/Madam,


I am directed to say that the Ministry has received demand from some quarters to extend the cut-off date for admissions in UG & PG courses in ASU&H colleges for the academic year 2017-18.

2. It has, therefore been decided to extend the cut-off date up to 31st October, 2017 for admission in ASU&H colleges for the academic session 2017-18 as a one-time measure subject to consideration of all admissions in the extended period by the concerned Universities and authorities involved in admission process for the academic session 2017-18 at par with all other students to be admitted before 30th September, 2017 and to allow all the admitted students under valid permission of the Central Government to appear in the subsequent examinations at the same time.

3. The Central Council of Indian Medicine and Central Council of Homoeopathy are hereby requested to notify immediately the extension of the cut-off date of admissions as above and circulate it to all concerned colleges, Universities and State Governments. It may also be placed on the Council's website for wider publicity.
